The Enemy Within

The Trump administration plans to challenge sanctuary city policies by charging state and local officials who oppose federal immigration. Constitutional Crisis?



There is much talk from Democrats and the mainstream media about a "Constitutional Crisis" created by President Trump's efforts working with Elon Musk and DOGE to dramatically cut federal spending by eliminating the massive waste fraud and abuse of your tax dollars. The President is acting fully within his authority under Article II, Section 1 of the US Constitution, "The executive Power shall be vested in a President of the United States of America."

Judges do not have executive powers. However, the "left" led by Rep. Jamie Raskin (MD) is resisting the President through activist judges who are acting outside their authority to:

- * Block the President's order eliminating birthright citizenship.
- * Stop foreign aid payments.
- * Restrain the President from banning "trans" medical care for minors.
- * Block the Consumer Financial Protection Bureau from terminating employees.

These rulings will be overturned upon appeal, and some may make it to the Supreme Court, where the resulting decisions will likely clarify and strengthen the Presidents sole executive authority.

Activist judges can be impeached and removed from the bench. Rep. Eli Crane (AZ) initiated the impeachment process for U.S. District Judge Paul Engelmayer, who attempted to block DOGE access to the Treasury Department. Make no mistake. It's not President Trump who's creating a "Constitutional Crisis", it's activist judges scrambling to cover corruption and undermine our Republic.
